Project Title: Los Angeles International Airport (LAX) Specific Plan Amendment Study (SPAS)

Project Location (include county): Los Angeles International Airport, Los Angeles County, CA 90045

Project Description: SPAS provides conceptual airfield, terminal, and ground access improvements. Key features include runway relocations and extensions; taxiway improvements, including a centerfield taxiway; modifications to terminals, including a new terminal; and new ground access facilities, including an Intermodal Transportation Facility, Consolidated Rental Car Facility, Automated People Mover, and connections to regional transit. City Council denied a CEQA Appeal filed by ARSAC, affirmed certification of the Final EIR, and concurred with the Board's action approving the combination of Alternatives 1 and 9 (Board of Airport Commissioners Approved Alternative, FEIR Section 2). SPAS includes General Plan and LAX Specific Plan amendments. The amendments to the General Plan were approved and direction given to the City Attorney's office to prepare the LAX Specific Plan ordinance.
